FREQUENTLY ASKED QUESTIONS

What is a Columbarium?

A Columbarium is free standing, constructed of numerous small compartments (niches) designed to hold urns that contain human remains.

What are the ground burial options?

Each plot offers you the option of a single burial or double depth burial, with the option of an additional 4 cremations for a maximum total of 6 burials per plot. Subject to change depending on area of cemetery as some of the older areas allow for cremations only or single graves.

What does double depth mean?

Double depth allows for the burial of two caskets in one plot. The first casket is placed in the plot at approximately a depth of 8 feet and the second casket is placed on top at the standard depth of 6 feet.

What is perpetual care?

This is the income used to provide regular care and maintenance at the cemetery in perpetuity. Regular care and maintenance can include but not limited to: cutting grass, regrading of graves, planting and caring for trees, maintenance of roads and drainage.

Can I sell my plot?

You may sell your plot back to the Town of Stettler at 85% of market value of the plot including the perpetual care or you can notify the Town of Stettler to transfer the rights to a family member.

Can we dig our own grave to avoid open/close costs?

The actual opening and closing of the grave is just one component of the fee charged. Due to safety issues which may arise around the use of machinery on cemetery property and for the protection of the adjacent graves the opening and closing of all graves at Lake View Cemetery must be conducted by the Town of Stettler employees only.

Can I put up my own handmade monument?

There are regulations according to our Cemetery Bylaw in regards to monuments and the installation of monuments and permit needs to purchase for a fee. A copy of our Cemetery Bylaw can be found on our website: www.stettler.net or by contacting the Town of Stettler.

Why do you need a Cemetery Bylaw?

WHEREAS every operator of a cemetery must adopt bylaws for the interment or other disposition of the deceased; respecting the organization, operation and management of the cemetery, including the setting of fees; the size, class and kind of memorials and materials used for memorials; and the rights, privileges and responsibilities of the operator, Interment Rights Holders and their relatives, other users, suppliers, funeral providers, memorial dealers and the general public.

Burial (Interment) Options

Plot (Earth Burial) Interment Options

The Town of Stettler Lake View Cemetery Bylaw 2085-16 has criteria for the interment of human remains, including standards for depth of the burial and size of the casket or grave liners for each 4X9 plot. It is recommended you call the Town of Stettler for details regarding plots.

All plot locations shall be determined as per the next available plot unless previously purchased. Additional plots may be purchased and reserved by the same individual to a maximum of 4 Plots.

Each plot in the new area, Block B offers you the option of single burial or double depth with the option of an additional 4 cremations for a maximum total of 6 burials per plot. This is subject to change depending on area of cemetery as some of the older areas allow for cremations or single graves only.

Columbarium (Cremations)

The Town of Stettler offers this alternative in our cemetery expansion. Each compartment is called a niche and it is used only for the purpose of placement of up to two cremated remains as space within the Niche permits.

Monuments

Any individual or company wishing to place a new monument or replace an existing monument MUST first obtain a permit from the Town of Stettler. The permit must be completed and returned to the Town of Stettler with the \$50.00 + GST permit fee prior to any work being completed. Monuments shall not be erected, repaired or replaced on Saturdays, Sundays or Holidays unless permission has been granted in writing by the Town of Stettler. 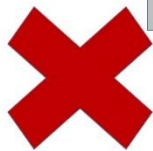
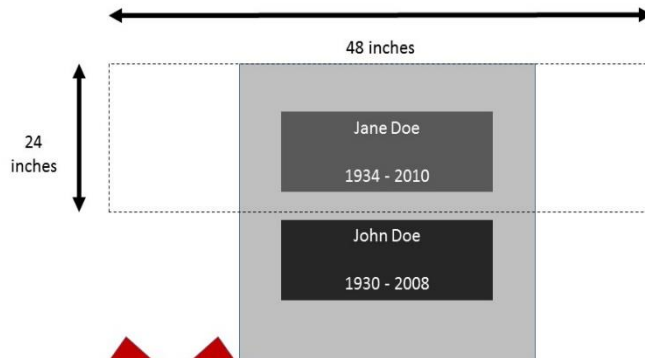
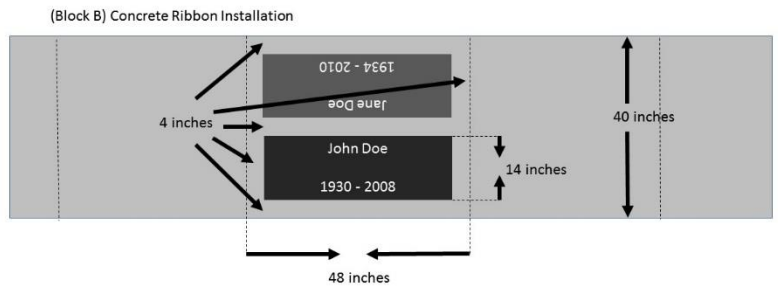
Please see below examples of an incorrect and correct monument installation. Monuments must be constructed of stone resistant material such as granite or bronze.

Monuments cannot be constructed of concrete or wood.

The maximum dimension of the concrete foundation shall be 24" X 48" per plot

Cemetery Grave Decorations

Our Cemetery Bylaw 2085-16 can be found on our website at www.stettler.net

The Town of Stettler realizes the sensitivity that Cemetery Grave Decorations may create however maintenance, care, and long term enjoyment of the Cemetery along with the safety of the public and Town of Stettler Employees of the Cemetery is held to high standards. Many Grave Decorations can be safety hazards to employees using maintenance equipment and to bystanders in the Cemetery. As such grave decorations shall conform to guidelines within our Cemetery Bylaw.

Some of the guidelines are as follows:

- Memorials such as candles, statues, decorative flags, stuffed animals, balloons, vases, tin cans, buckets, solar lights, or any other materials that are **permanently attached** to the Monument or Marker are permitted.
If not permanently attached to the Monument or Marker, the memorial shall be removed by Cemetery personnel without notice.
- Artificial flowers, including the holder are only permitted if permanently contained within the Monument or Marker. Cut fresh flowers are permitted on Graves, however will be removed by Cemetery staff without notice if they become unsightly, wilted or become wind strewn.
- Glass Grave Decorations of any kind will not be permitted and will be removed by Cemetery personnel without notice.
- Plantings of any kind are not permitted on Graves and will be removed without notice.

On a regular basis throughout the year staff shall inspect and remove from Plots in the Cemetery all non-permitted plantings, shrubs, and Grave Decorations.
